Household Income

You are eligible to receive a bonus rebate if your income is at or below the income guidelines listed below. Income is defined as the total annual gross income of all family and non-family members 18+ years old living within the household. To calculate income, take the monthly amount that you and the people in your household are paid before taxes and multiply by 12. Include all wages, including regular salaries and overtime. If you are self-employed, use the previous 12 months of pretax income.

All sources of income must be counted from all persons in the household based on anticipated income expected within the next 12 months. Possible types of income include but are not limited to: wages, salary, tips, bonuses or commissions payments, public assistance, social security/SSI, child support, regular gifts, unemployment, income earned on assets (savings, IRA, etc.) and some types of financial aid.
