### Energy Co-op of Vermont: Easy Pay Pellets Plan Terms and Conditions

These terms and conditions shall apply to my agreement for monthly payments and deliveries of wood pellets manufactured by Vermont Wood Pellets, LLC, or LG Granules (“Wood Pellets”) from September 1, 2020 through May 31, 2021 (the “Season”) by the Energy Co-op of Vermont (the “Co-op”) under its Easy Pay Pellets Plan for Co-op members (“Easy Pay Members”).

- Easy Pay Members hereby purchase the number of tons of Wood Pellets shown on the first page of this agreement at the price shown. This is the total number of tons purchased under this Agreement and is the maximum amount that the Co-op will deliver to you at this price during the Season. **The Co-op’s minimum delivery is two tons. All wood pellets will be delivered in 1 trip.**
- During the Season, changes in the Co-op’s Wood Pellets prices will not change the price Easy Pay Members pay for Wood Pellets purchased under the terms of this Agreement.
- Easy Pay Members agree to make monthly payments to the Co-op during the Season. These payments are due by the 20th day of each month.
- If Easy Pay Members fail to make a payment within 30 days of the due date, the Co-op has the right to terminate this agreement immediately upon written notice to the Easy Pay Member. • This signed and completed agreement is due by October 31, 2020 and must be included with payment of the amount shown as “Total Enclosed” on the first page of this agreement.
- Easy Pay Members agree to contact the Co-op at least three weeks before they require a Wood Pellet delivery during the Season. • **The Co-op reserves the right to deliver the wood pellets prior to December 31<sup>st</sup>. Deliveries between January 1 and March 15<sup>th</sup> are on a best efforts basis.** If an Easy Pay Member’s account has a credit balance at the end of the season, the Co-op may apply this credit balance towards future deliveries, unless the Easy Pay Member requests a refund, in writing, by June 15th, 2021. All such refund requests will be satisfied by the Co-op on or before June 30th, 2021. • **This offer is limited and will be available on a first-come basis. Enrollment expires on Thursday October 31, 2020 or whenever the available supply of wood pellets is exhausted, whichever comes first.**
